ELIGIBILITY

HOW TO ENTER – PROMOTION PERIOD

Fans can enter to win by following @seattlebaking on Instagram and ‘liking’ the required photo. The contest will begin on May 4th, 2019 12:00 AM PST and go until May 17th, 2019 11:59 PM PST. Only those who follow the @seattlebaking Instagram will be eligible for the prize drawing. There is no purchase is necessary to enter.

PRIZING – SELECTED WINNERS

One winner will be chosen at random by the Franz Marketing Committee the week of May 19th, 2019 from among all the eligible entries received. Only one prize per person. The Administrator’s decision is final and binding in all matters. The winners will be notified via Direct Message on Instagram and will be asked to reply with their contact information to receive their prize by mail. The winner must claim their prize within 3 days of the time of notification or a secondary winner will be drawn. Failure to respond to the notification of winning within the specified time period in the notification, the return of any prize notification as
